## Ok Tedi Environmental Disaster (1984)

The Ok Tedi River and the Fly River are located in the Western Province of Papua New Guinea. Between about 1984 and 2013 the lives of 50,000 people have been disrupted as a consequence of the discharge of about two billion tons of untreated mining waste into the Ok Tedi from the Ok Tedi Mine, an open pit mine in the Western Province of Papua New Guinea.

This mining pollution majorly happened due to collapse of the Ok Tedi tailing dam system in 1984 and absence of waste retention facility.

In 1999, it was reported that 90 million tons of mine waste was annually discharged into the river for more than ten years and destroyed downstream villages, agriculture and fisheries. Mine wastes were deposited along 1,000 kilometres (620 mi) of the Ok Tedi and the Fly River below its confluence.

Following heavy rainfall, mine tailings are swept into the surrounding rain forest, swamps and creeks, and have left behind 30 square kilometres of dead forest. Thick gray sludge from the mine is visible throughout the Fly River system.

Chemicals from the tailings killed or contaminated fish, although they are still eaten by the people of the surrounding villages. The massive amount of mine-derived waste dumped into the river exceeded its carrying capacity. This dumping resulted in the river bed being raised 10 m, causing a relatively deep and slow river to become shallower and develop rapids, thereby disrupting indigenous transportation routes.

# **Kolkata Nursing Home: Cradle for Trafficking Newborns**

November, 2016. Owner and a doctor at Shri Krishna Nursing Home, Kolkata along with staffs from a state NGO were arrested in connection with the inter-state newborn trafficking racket busted in Baduria.

Sujit Dutta Memorial Welfare Trust, the NGO would lure childless couples under the guise of facilitating adoptions and sell newborns to them.

According to sources, the NGO would liaise with nursing home staffs, who would either facilitate deliveries of unmarried women or dupe new parents into believing their babies were stillborn and handover the babies to the NGO, where they would sell them to childless couples. Police while investigation rescued two newborns wrapped in cotton and hidden in an unhygienic manner inside a biscuit carton.

The racket has been operating for the past three years and involved dozens of nursing homes in Kolkata catering to customers from Mumbai and Delhi.

James is an engineer working for the company AERO that produces aeroengines. The company is developing a new type of aero-engine called the FANX. James is responsible for the testing of the FANX. He is in the middle of conducting a range of crucial tests for the reliability of the new aero-engine. Yesterday, Bill – who is James' boss - has asked James to finish his test reports within a week because an important potential customer will visit AERO next week and wants to have a look at the first test reports. James' first reaction is to refuse Bill's request: he is not able to finish the test report within a week; he first needs to do more tests. James considers these additional tests crucial for gaining good insight in the reliability of the FANX. Bill tells James to abandon the planned other tests and to start writing his report immediately. Later, there will be more time to do the other tests. Bill also tells James that if James refuses he will ask Eric to write the report. James says that he really needs more time. Moreover, he objects, Eric is not knowledgeable of the tests and will not be able to write a sound report. After the meeting, James contacts Eric who says that he agrees with Bill and that he will write the report if Bill asks him to do so.

#### Kolkata AMRI Fire Case

December, 2011. At least ninety people were killed in a fire that ravaged the AMRI, Dhakuria, Kolkata, in the early hours. Most of the victims chocked to death as smoke engulfed the building.

Fire broke out around 3 a.m in the basement of the seven-storey building of the AMRI Hospital (Dhakuria) and swept through the top threatening lives of 164 in-patients.

The building is centrally air-conditioned and there is no ventilation channel for the smoke to come out, even desperate fire fighters smashed glass windows to let fumes out. The basement where the fire started housed a pharmacy, a central storeroom and biomedical department, all containing inflammable articles. Trepidations rose when hospital authorities informed
